Social behavior and citizen's awareness are considered an important factor in dealing with this pandemic".

Asharhani & Gupitasari (2021) and Haryono & Pramitasari (2021) with reorganizing the home habits show that response of working from home adaptations. While Laksmiyanti, Nareswananindya & Hidayat (2021) identify the people's opinion of cinema precondition toward the government restriction. Denis et al (2021) present the other perspective of response with protest research. In the current Indonesia issue of PPKM removal, there is still no scientific paper that spots this topic. Therefore next segment will study more emerge issue with popular literature from online news.

### POPULAR LITERATURE STUDY

There are many reputable Indonesia media online, such : antaranews, cnnindonesia, cnbc, Kompas have reported the probability of the Indonesia authority lifting the restriction on the May 2022. Some of them also showed that public building and tourism object have already crowded with people especially after the event of lebaran 2022. The Indonesia government has permitted the mudik wave on last lebaran.

Some media like Kompas on (2021) and (2022) put both side perspective of design that respond pandemic and just clearly flow the previous agenda of more open and liberal design.
